The above amendment was reviewed at the meeting of the Committee held on 07 September 2010.

Ethical opinion

Favourable Opinion

The amendment (dated 12 July 2010) sought approval introduce electronic data collection. A move towards electronic data collection was considered to be vital for the ongoing success of the BSRBR as it was hoped that the comparative ease of the new system would encourage clinicians and research nurses to submit data to the Register in a more efficient way as well as reducing the scope for data entry error, as the information would be entered directly at source in the hospital rather than by a separate data-entry team.

A comprehensive, clear and well written rational had been provided in support the amendment. In addition, a revised Participant Information Sheet and Consent Form had been submitted for review.

The Committee noted with interest that it was intended to pilot the new system at eight centres across the UK, before extending the system to all centres, and that the issues regarding data protection had been considered.

The Committee identified no ethical issues with the proposed amendment.

The members of the Committee taking part in the review gave a favourable ethical opinion of the amendment on the basis described in the notice of amendment form and supporting documentation.
